- Provide your existing trading name as currently recorded with Licensing Services (Security)

### Required Documents

#### LOCAL GOVERNMENT APPROVAL

Local government approval must be provided with written evidence issued by the local district advising the location proposed has obtained all approvals, consents and exemptions required under any written law, in relation to the premises.

i.e. Letter from the local government confirming there's no objections for the premises to be utilised for the desired licence type.

#### TRADING NAME DOCUMENTATION

To add a trading name the supporting document, Record of Registration for Business Name from the Australian Securities & Investment Commissions (ASIC) is to accompany this form

#### CHANGE OF NAME DOCUMENTATION

To legally change any part of your name, you must provide written evidence from Births, Deaths and Marriages, along with a current form of photo identification stating your new name.
