Documents to Support Application

Documents for Required

- · Application Form, including Code of Conduct
- · Copy of Current State or Terrority's Security Licence and Identification Card
- Copy of Current First Aid Certificate (Security Officer, Crowd Controller, Security Bodyguard)
- Passport photographs

A set of four (4) passport size photographs is to be included with each application. These photographs are to:

- · Display the head and shoulders (full face);
- Be on a white or very light background;
- · No eye altering contact lenses or shaded glasses are to be worn.
- Letter of Intent from proposed Western Australian Agent outlining that they have offered employment to the applicant, and the time and occasion of the specified event or function in respect to why the licence is required.
- Baton and Firearm Endorsement (if applicable) documents to support that the applicant has a current firearm/baton endorsement and that their training is current.
- Baton and Firearm Endorsement (if applicable) a letter of intent from agent stating why temporary licence is required, the types of duties to be performed and that a firearm is required.
- · ASIC Business registration certificate and extract

Penalties apply for omissions, false or misleading information.

Additional Information

A Temporary Licence cannot exceed a period of 12 months and is not renewable
