In order to become an 'Approved Warehouseman' the following information must be provided with your application:

- Premise and building details, including floor plan;
- Storage facility details - Storage of firearms and ammunition must meet the requirements of Schedule 4 of the Firearms Regulations 1974 or be approved as alternate to Schedule 4. Any handgun subject of a Dealer, Repairer or Manufacturer's licence must be stored in accordance with the WA Police Dealer, Repairer and Manufacturers Handgun Security Policy;
- Details of operational procedures in place to ensure safe storage and handling of firearms and or ammunition;
- A Nominated Person Application for any persons who will have access to the firearms and or ammunition;
- Details of any other security measures implemented for the storage and handling of firearms and ammunition;
- Include a completed Form 22 Storage Statement, with full colour quality photographs of any storage cabinet or storage container that will be used to store firearms or ammunition during transportation.
