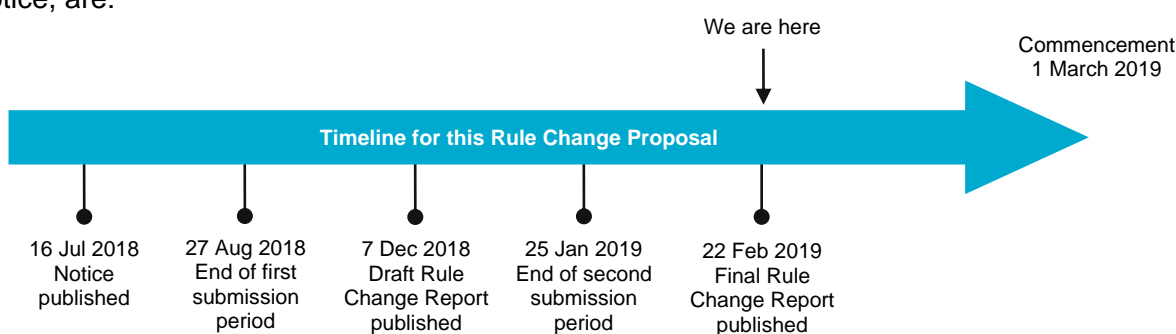
1. Rule Change Process and Timeline

On 6 July 2018, the Australian Energy Market Operator (**AEMO**) submitted a Rule Change Proposal seeking to remove Gas Bulletin Board (**GBB**) Zones from the Gas Services Information (**GSI**) Rules (**GSI Rules**).

The Rule Change Proposal was progressed via the Standard Rule Change Process described in Division 4 of Part 8 of the GSI Rules.

On 28 August 2018, the Rule Change Panel extended the timeframe for the publication of the Draft Rule Change Report in accordance with subrule 141(1) of the GSI Rules. Further details of the extension is available on the Rule Change Panel's website.

The key dates for progressing the Rule Change Proposal, as amended in the extension notice, are:



The Rule Change Panel's final decision is to accept the Rule Change Proposal in a modified form, as set out in section 7 of this Final Rule Change Report.

2. Proposed Amendments

2.1 The Rule Change Proposal

The GSI Rules require AEMO to publish and display certain information on the GBB by Zone (**GBB Zones**). The GBB Zones include specified GBB Pipelines (or parts of GBB Pipelines) and all Receipt Points and Delivery Points connected to those pipelines (or parts of pipelines).

The GBB Zones are currently specified in Schedule 2 of the GSI Rules, which means that a rule change is required to allocate a new GBB Pipeline to a GBB Zone, or to reallocate existing GBB Pipelines to different GBB Zones.

In the Rule Change Proposal, AEMO sought to:

- remove the GBB Zones from the GSI Rules and instead specify the GBB Zones in the GSI Procedure: GBB Registration, Deregistration, Exemptions and Transfer (**Registration Procedure**); and
- develop guidelines for the allocation of a GBB Pipeline to a GBB Zone and the revision of GBB Zones to accommodate future gas market developments, and include those guidelines in the Registration Procedure.

2.2 The Rule Change Panel's Initial Assessment of the Proposal

The Rule Change Panel decided to progress the Rule Change Proposal based on its preliminary assessment that the Rule Change Proposal is consistent with the GSI Objectives.

3. Consultation

This issue with respect to the management of the GBB Zones was initially identified in a review of the GBB Zones by the Independent Market Operator (**IMO**) in 2015. The IMO engaged Marsden Jacob Associates to assist it in undertaking the GBB Zones Review.¹ For present purposes, the review, which included a public consultation process to obtain feedback from Gas Market Participants, concluded that prescribing the GBB Zones in the GSI Rules was unnecessary, and added to the regulatory burden of the IMO and Gas Market Participants.

3.1 The Gas Advisory Board

The Gas Advisory Board (**GAB**) considered the administrative complexities and costs associated with managing the GBB Zones, which resulted in the development of a Pre-Rule Change Proposal by AEMO. AEMO's Pre-Rule Change Proposal was circulated to the GAB on 15 May 2018. No comments or issues were raised on the proposal, so AEMO submitted the Rule Change Proposal on 6 July 2018.

3.2 Submissions Received During the First Submission Period

The first submission period for the Rule Change Proposal was held between 16 July 2018 and 27 August 2018. Submissions were received from Alinta Energy (**Alinta**) and AGL Energy (**AGL**).

The submissions generally supported the proposed Amending Rules.

Alinta suggested minor changes to the drafting of the proposed Amending Rules regarding the proposed obligation on AEMO to develop guidelines for allocating pipelines to GBB Zones and reviewing GBB Zones. Alinta expressed the view that the Registration Procedure should set out the process AEMO needs to follow, and not just outline some high-level guidelines that AEMO needs to take into account when allocating or reallocating GBB Pipelines to GBB Zones.

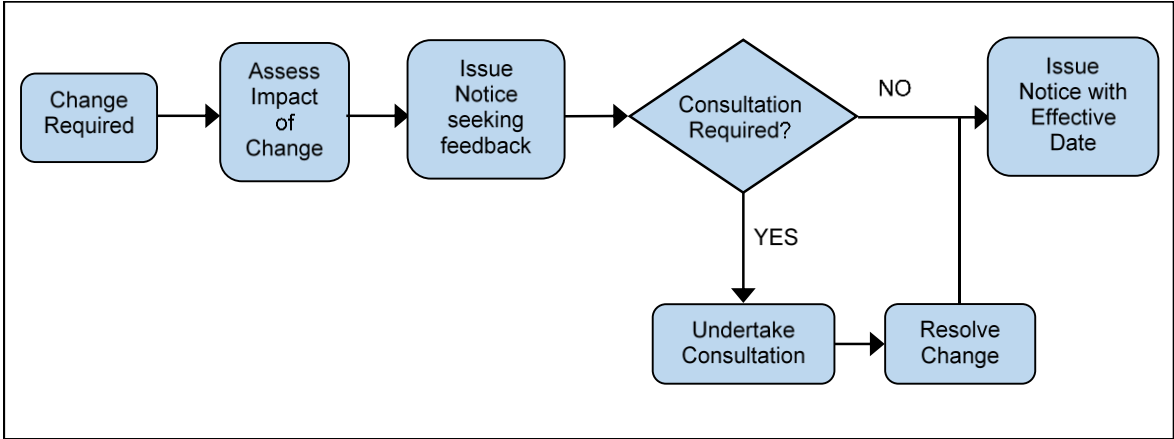
AGL expressed support for measures to reduce unnecessary regulatory burden, but noted that a pre-set consultation process and associated timelines would still need to be followed to amend GBB Zones if the amendment process is placed in a GSI Procedure. Instead, AGL proposed that the GBB Zones be considered as administrative information, and published in a separate reference document that is not subject to the same regulatory change processes as the GSI Rules or GSI Procedures.

AGL proposed that the GBB Zones could be published in a separate reference document that is not directly subject to consultation. AGL proposed that the GSI procedure could include a decision-making framework for GBB Zones that should enable minor changes, in cases where Gas Market Participants do not raise issues with them, to be made quickly and

with minimal regulatory burden. AGL suggested that amendments that are contentious or have a substantial impact would require AEMO to undertake an appropriate consultation process. AGL’s suggested framework is set out in Diagram 1.

Diagram 1: AGL’s suggested decision-making framework



AGL’s proposed approach involves AEMO publishing an initial notice seeking feedback on a proposed change to the GBB Zones reference document. If no issues are raised by Gas Market Participants, AEMO would proceed immediately to a final notice with an effective date that commences the amendments to the GBB Zones reference document. If Gas Market Participants raise issues regarding a proposed amendment, AEMO would be required to undertake an appropriate consultation process.

Neither of the submitting parties provided an assessment of whether the Rule Change Proposal would better achieve the GSI Objectives.

Copies of all submissions received during the first submission period are available on the Rule Change Panel’s website.

3.3 The Rule Change Panel’s Response to Submissions Received During the First Submission Period

The Rule Change Panel’s response to each of the specific issues raised in the first submission period is detailed in Appendix A of the Draft Rule Change Report for the Rule Change Proposal, which is available on the Rule Change Panel’s website. A more general discussion of the Rule Change Proposal, which addresses the main issues raised in the submissions and the Rule Change Panel’s response to these issues, is available in section 5 of this report.

3.4 Submissions Received During the Second Submission Period

The second submission period for the Rule Change Proposal was held between 7 December 2018 and 25 January 2019. The Panel received two submissions – from AEMO and AGL.

AEMO considers that the modified Amending Rules in the Draft Rule Change Report will better achieve the intent of the original Rule Change Proposal and the GSI Objectives by further reducing the administrative costs associated with changes to the GBB Zones.

Further, as to whether the Rule Change Proposal would better achieve the GSI Objectives, AEMO agrees with the Rule Change Panel’s assessment in the Draft Rule Change Report, which is available on the Rule Change Panel’s website.

AGL expressed support for the changes in the Draft Rule Change Report which it considers provides for a process which minimises regulatory requirements on the market by allowing administrative matters to be dealt with efficiently and only requiring consultation processes when issues have an impact on market participants. AGL believes that this style of regulation removes unnecessary regulatory burden on all market participants whilst retaining appropriate controls and consultative mechanisms.

3.5 The Rule Change Panel's Response to Submissions Received During the Second Submission Period

No issues were raised during the second submission period.

3.6 Public Forums and Workshops

No public forums or workshops were held in regard to the Rule Change Proposal.

4. The Rule Change Panel's Draft Assessment

The Rule Change Panel's draft assessment against rules 127 and 128(1) of the GSI Rules and analysis of the Rule Change Proposal are provided in sections 5.1 and 5.2 of the Draft Rule Change Report, which is available on the Rule Change Panel's website.

5. The Rule Change Panel's Proposed Decision from the Draft Rule Change Report

The Rule Change Panel's proposed decision was to accept the Rule Change Proposal as modified by the following amendments. These amendments were originally outlined in section 5.3 of the Draft Rule Change Report and reflected in the modified Amending Rules presented in section 7 of the Draft Rule Change Report.

- AEMO is to be required to develop, maintain and publish on the GSI Website a reference document, to be known as the GBB Zone List. The initial version of the GBB Zone List is to be based on the GBB Zones specified in Schedule 2 of the GSI Rules.
- In deciding whether to make a change to the GBB Zone List, AEMO is required to have regard to the following matters, which are based on the relevant decision-making criteria specified in rules 127 and 128(1) of the GSI Rules:
 - (a) the proposed change is to be consistent with the GSI Objectives;
 - (b) the practicality and cost of making the proposed change;
 - (c) the views expressed in any submissions received by AEMO on the proposed change; and
 - (d) any information that AEMO considers necessary to assess whether or not to make the proposed change.
- If AEMO proposes to make a change to the GBB Zone List, AEMO will be required to follow the steps below:
 1. AEMO is required to publish a notice on the GSI Website that:
 - gives details of the proposed change;

- states why the proposed change is required and the effects of the proposed change; and
 - invites submissions objecting to the proposed change within a period specified in the notice, being at least five business days.
2. If no objections are raised, then AEMO can proceed to issue a notice stating the date from which the change will take effect; and
 3. If an objection is raised, AEMO will be required to undertake consultation in accordance with the GSI Consultation Procedure.²

The Rule Change Panel made its draft decision on the basis that the proposed Amending Rules, as modified in section 7 of the Draft Rule Change Report:

- will remove unnecessary administrative costs to Gas Market Participants by placing the GBB Zones in a reference document that is not subject to the same regulatory processes as the GSI Rules or GSI Procedures, and therefore will cost less to update and maintain;
- will enable administrative amendments to be addressed quickly and easily;
- will change the decision-maker from the Rule Change Panel to AEMO, which is appropriate because the GBB Zones are primarily an operational matter;
- will better achieve GSI Objectives (a), (b) and (d); and are consistent with the remaining GSI Objective (c); and
- impose no significant costs on Gas Market Participants.

6. The Rule Change Panel's Final Assessment

6.1 Assessment Criteria

In preparing its Final Rule Change Report, the Rule Change Panel must assess the Rule Change Proposal in light of rules 127 and 128(1) of the GSI Rules.

Rule 127 outlines that the Rule Change Panel "*must not make Amending Rules unless it is satisfied that the Rules, as proposed to be amended or replaced, are consistent with the GSI Objectives*". Additionally, rule 128(1) of the GSI Rules states that when deciding whether or not to make Amending Rules, the Rule Change Panel must have regard to:

- any applicable statement of policy principles given to the Rule Change Panel under rule 126;
- the practicality and cost of implementing the Rule Change Proposal;
- the relevant views expressed in any submissions received by the Rule Change Panel on the Rule Change Proposal;
- the relevant views expressed at any public forums or workshops, or in other consultation with Gas Market Participants, held by the Rule Change Panel on the Rule Change Proposal;

² The GSI Consultation Procedure is specified in rule 7 of the GSI Rules, and states that if the GSI Rules require AEMO to make an instrument in accordance with the GSI Consultation Procedure, then AEMO must publish a draft instrument and invite written submissions on the draft. The submission period must be at least 20 business days and AEMO must publish submissions on the GSI website, and consider each submission in developing the instrument in its final form. AEMO must prepare a written notice stating the reasons for making the instrument in its final form.

- the relevant views expressed by the GAB where it met to consider the Rule Change Proposal; and
- any information that the Rule Change Panel considers necessary to assess the Rule Change Proposal.

In making its final decision, the Rule Change Panel has had regard to each of the matters identified in rules 127 and 128(1) of the GSI Rules as follows:

- the Rule Change Panel's assessment of the Rule Change Proposal against the GSI Objectives is available in section 6.4 of this report;
- the Rule Change Panel notes that there has not been any applicable statement of policy principles from the Minister in respect of the Rule Change Proposal;
- the Rule Change Panel's assessment of the practicality and cost of implementing the Rule Change Proposal is available in section 6.5 of this report;
- a summary of the views expressed in submissions and by the GAB, and the Rule Change Panel's response to these views, is available in section 3 this report; and
- the Rule Change Panel notes that it did not require additional information in respect of the Rule Change Proposal.

The Rule Change Panel's assessment is presented in the following sections.

6.2 Assessment of the Proposed Changes

6.2.1 Removal of GBB Zones from the GSI Rules

The Rule Change Proposal seeks to remove the GBB Zones listed in Schedule 2 of the GSI Rules and specify them in the Registration Procedure. The Rule Change Panel agrees with AEMO in that moving the list of GBB Zones out of the GSI Rules will allow greater flexibility to amend the GBB Zones to suit market needs. However, the Rule Change Panel notes that if the GBB Zones are specified in the Registration Procedure, any amendments to the GBB Zones, including for minor or administrative and non-contentious changes, will require AEMO to follow the Procedure Change Process specified in the GSI Rules.³ The Rule Change Panel also notes that the process would take at least 20 business days from the date of publication of the Procedure Change Proposal to complete.⁴

As outlined in section 3.2 of this report, AGL has proposed an approach that involves AEMO publishing an initial notice seeking feedback on a proposed change to the GBB Zones reference document, and if no issues are raised by Gas Market Participants, AEMO would proceed immediately to a final notice with an effective date for the commencement of the amendments to the GBB Zones reference document. If Gas Market Participants raise any issues regarding a proposed amendment, AGL suggests that AEMO would be required to undertake an appropriate consultation process. The Rule Change Panel agrees that this proposed framework would better address the unnecessary regulatory burden of the current framework in the GSI Rules, and would not require the Procedure Change Process to be followed in the first instance, particularly for minor or administrative and non-contentious changes. AGL has not suggested what an appropriate consultation process would entail.

However, the Rule Change Panel considers the process prescribed in the GSI Consultation Procedure would be suitable.

The Rule Change Panel also notes that AGL's proposed framework, as proposed to be modified by the Rule Change Panel as outlined in section 5 of this report, will move the administrative burden of deciding changes to GBB Zones from the Rule Change Panel to AEMO. The Rule Change Panel supports this change as the allocation, or reallocation, of GBB Pipelines to GBB Zones is primarily an operational matter.

Therefore, the Rule Change Panel supports the introduction of the framework proposed by AGL, but in a modified form as outlined in section 5 of this report and the proposed Amending Rules in section 8 of this report.

6.2.2 Development of guidelines for the allocation of new pipelines to the GBB Zones and the revision of GBB Zones

The Rule Change Proposal seeks to introduce a requirement for AEMO to develop and maintain a GSI Procedure that includes guidelines for the allocation of new GBB Pipelines to the GBB Zones and the revision of GBB Zones. Alinta expressed the view that the Registration Procedure should set out the process AEMO needs to follow, and not just outline high-level guidelines that AEMO needs to take into account when allocating, or reallocating GBB Pipelines to GBB Zones. The Rule Change Panel does not consider that guidelines in a GSI Procedure are necessary, or appropriate, on the basis that the decision-making criteria for AEMO to amend the GBB Zones should be consistent with the criteria that the Rule Change Panel must consider when deciding whether to amend the GSI Rules, as specified in rules 127 and 128(1) of the GSI Rules. Further, by including the proposed framework in the GSI Rules, there will be appropriate governance oversight of the proposed framework.

Therefore, the Rule Change Panel supports basing the assessment criteria that AEMO must use in deciding whether to change the GBB Zones reference document on the decision-making criteria specified in rules 127 and 128(1) of the GSI Rules, as outlined in section 6.1 of this report.

6.3 Additional Amendments to the Proposed Amending Rules

Following the first submission period, the Rule Change Panel made some additional changes to the proposed Amending Rules. A summary of these changes is provided in section 5 of this report and was originally presented in section 5.3 of the Draft Rule Change Report, which is available on the Rule Change Panel's website.

These changes were part of the second submission period consultation. The two submissions – from AEMO and AGL – supported the proposed changes to the proposed Amending Rules.

The Rule Change Panel has not made any additional changes following the second submission period.

6.4 Assessment against the GSI Objectives

The Rule Change Panel considers that the Rule Change Proposal, subject to the proposed modifications outlined in section 5 of this report, will better achieve GSI Objectives (a), (b) and (d), and are consistent with the remaining GSI Objective (c). This is because:

- GBB Pipelines will be able to be allocated, or reallocated, to GBB Zones via a simple framework that means, for minor or administrative and non-contentious changes in particular, AEMO will be able to publish and display the relevant information for each of the GBB Zones more appropriately and quickly (GSI Objectives (a) and (d)); and
- reducing the administrative effort and time required to update the GBB Zones will reduce the costs to Gas Market Participants, and promote the efficient operation and use of natural gas services in the State (GSI Objective (b)).

6.5 Practicality and Cost of Implementation

6.5.1 Cost

AEMO has confirmed that the Rule Change Proposal will require minor changes to AEMO's internal procedures and work instructions. Further, these changes will be accommodated as a part of AEMO's operational budget.

6.5.2 Practicality

AEMO has confirmed that the GBB already contains the required functionality to manage changes to the GBB Zones, so no systems changes will be required.

AEMO expects that changes will be required to AEMO's internal procedures and work instructions to reflect the proposed Amending Rules, but the changes are expected to be very minor and will be managed under its business as usual operations.

AEMO considers the proposed commencement date of 1 March 2019 allows sufficient time for AEMO to update its internal procedures and publish the GBB Zones on the GSI website.

7. The Rule Change Panel's Decision

Based on the considerations set out in this Final Rule Change Report, the Rule Change Panel's final decision is to accept the Rule Change Proposal in a modified form, as set out in the Amending Rules in section 8 of this Final Rule Change Report.

7.1 Reasons for the Rule Change Panel's Draft Decision

The Rule Change Panel has made its decision on the basis that the Amending Rules:

- will remove unnecessary administrative costs to Gas Market Participants by placing the GBB Zones in a reference document that is not subject to the same regulatory processes as the GSI Rules or GSI Procedures, and therefore will cost less to update and maintain;
- will enable administrative amendments to be addressed quickly and easily;
- will change the decision-maker from the Rule Change Panel to AEMO, which is appropriate because the GBB Zones are primarily an operational matter;
- will better achieve GSI Objectives (a), (b) and (d); and are consistent with the remaining GSI Objective (c); and
- impose no significant costs on Gas Market Participants.

7.2 Proposed Commencement Details

The Amending Rules commence at **8:00 AM** on **1 March 2019**.

8. Amending Rules

The Rule Change Panel has decided to implement the following Amending Rules (~~deleted text~~, added text, clauses that are included for context but not amended):

...

82 Zones

- (1) Schedule 2 lists the Zones used for the GBB information display. AEMO must develop and maintain the GBB Zone List.
- (2) The Zones listed in the table at Part 5 of Schedule 3 of the Rules must be the Zones specified in the initial version of the GBB Zone List.
- (3) AEMO must publish the latest version of the GBB Zone List on the GSI Website.
- (4) AEMO must not make a change to the GBB Zone List unless it is satisfied that the proposed change is consistent with the GSI Objectives.
- (5) If AEMO proposes to make a change to the GBB Zone List, AEMO must publish a notice on the GSI Website:
 - (a) giving details of the proposed change;
 - (b) stating why the proposed change is required and the effects of the proposed change;
 - (c) inviting submissions objecting to the proposed change within a period stated in the notice, which must be at least five Business Days; and
 - (d) stating the proposed commencement date of the change, if no objections are received.
- (6) On the same day that the notice under subrule (5) is published, AEMO must inform Gas Market Participants that the notice has been published.
- (7) If AEMO does not receive an objection in response to a notice published under subrule (5) within the time specified in the notice, AEMO must make the change specified in the notice to the GBB Zone List and publish the amended GBB Zone List on the GSI Website, together with the date the change will take effect.
- (8) If AEMO receives an objection in response to a notice published under subrule (5) within the time specified in the notice, then AEMO must consult on the proposed change to the GBB Zone List in accordance with the GSI Consultation Procedure.
- (9) In deciding whether or not to make a change to the GBB Zone List, AEMO must have regard to the following:
 - (a) the practicality and cost of making the proposed change;

(b) the views expressed in any submissions received by AEMO on the proposed change; and

(c) any information that AEMO considers necessary to assess whether or not to make the proposed change.

~~(2)(10)~~ AEMO may review the Zones, and must do so at least once in each five year period.

~~(3)(11)~~ A review of the Zones must be carried out in consultation with Gas Market Participants and gas industry groups.
