

Application for exemption under regulation 5(1)(a)

Waste Avoidance and Resource Recovery Levy Regulations 2008

Regulation 5 of the Waste Avoidance and Resource Recovery Levy Regulations 2008 sets out the circumstances under which licensees can apply to claim an exemption from the regulations.

Licensees are required to use this form to apply for an exemption under regulation 5(1)(a) being:

Waste that:

- (i) was accepted by the licensee at no charge
- (ii) is, or will be, used after the completion of landfill operations to cover waste disposed of at the licensed landfill in compliance with the conditions on the licence or any implementation conditions as defined in the *Environmental Protection Act 1986* section 3(1).
