

Request for Ruling on Revocation of Exemption for Relevant Transaction

Chapter 6 of the Duties Act 2008

Chapter 6 of the Duties Act provides for an exemption from duty for relevant consolidation transactions and relevant reconstruction transactions. The exemption may be revoked in certain circumstances.

When to use this form

Use this form to ask that, if a transaction were entered into, would the Commissioner revoke the exemption previously granted for a relevant consolidation or reconstruction transaction.

How to lodge this form

Proposed transaction

Provide:

- a copy of the agreement, deed, completed transfer duty statement or acquisition statement or certificate of exemption relating to the previously exempted relevant consolidation or reconstruction transaction and
- a draft of the instrument, transfer duty statement or acquisition statement relating to the proposed transaction or other matter that may trigger a revocation.
