

Factsheet PEN01 Offences and penalties Employees, volunteers, students and selfemployed

There are a range of penalties for not complying with the <u>Working with Children (Screening) Act</u> <u>2004</u> (the Act). This factsheet provides a summary of the offences and penalties that apply to employees, **volunteers**, **students**, and self-employed people engaged in <u>child-related work</u>. For the exact wording of offences please refer to the Act.
