Introduction

Each year the State Records Office of WA (**SRO**) publishes an online Guide to State Cabinet records which have been released in the previous calendar year. Archived records of Western Australian State Cabinet are released for public access 30 years after the records are created.

State Cabinet records are historically significant documents which reveal the decisions made by the government of the day. These unique records are the primary source documents for information about the issues raised at Cabinet meetings. This online Guide is intended to assist the Western Australian community to access these records.

This year's Guide reviews State Cabinet records, which comprise the minutes and decisions Cabinet, dating from 16 February through to 20 December 1993. The Guide also provides an overview of Western Australian state issues in 1993, as well as highlighting a few prominent national and international news events of that year for context. A list of the topics and subjects discussed at each meeting of State Cabinet in 1993 is provided in this Guide to assist with further research into the records. This list includes a link to the SRO's online catalogue to enable the public to view relevant State Cabinet records online.

This year (2024) the Guide to the 1993 State Cabinet Records has been produced with the assistance of Ms Sarah Edland, Bachelor of Arts (Archaeology) student from the University of Western Australia during a McCusker Centre for Citizenship Internship at the SRO. During her placement Ms Edland researched 1993 State Cabinet Minutes and Decisions and Meeting Summaries, compiling a detailed list of Cabinet meeting subjects, as well as compiling sections on world, national and local events.

State Cabinet Records are held by the SRO, the entity responsible for identifying, managing, preserving, and providing access to the State's Archives. Some of the State Cabinet Records listed in this Guide can be accessed online via the SRO's catalogue at: <https://archive.sro.wa.gov.au>.

All of the original records are available for viewing on request in the Reading Room on the third floor of the Alexander Library Building in the Perth Cultural Centre. World Events that Made the News in 1993¹

In global politics, Bill Clinton was sworn in as the 42nd President of the United States in January 1993. In the same year Edouard Balladur became Prime Minister of France, the Sri Lankan President, Ranasinghe Premadasa, was assassinated by a Tamil Tiger suicide bomber, Ezer Weizman was elected President of Israel, and Kim Campbell was sworn in as the first female Prime Minister of Canada, lasting only 132 days before losing a landslide election in November.

In October 1993 Nelson Mandela and F.W. De Klerk were both awarded the Nobel Peace Prize. They received the award jointly for their work for the peaceful termination of the apartheid regime and for laying the foundations for a new democratic South Africa.

In the United Kingdom, Buckingham Palace opened to the public for the first time. For an entrance fee of £8 the public could see the State Apartments and royal collections of paintings, porcelain and furniture. The funds were to aid the repair of Windsor Castle which had been ravaged by fire in 1992.

In Literature, Arts and Entertainment, the coveted Pulitzer Prize was awarded to Tony Kushner for his play "*Angels in America: Millennium Approaches*." The work explored gay life in the early days of the AIDS crisis, before transmission was widely understood or effective treatment available. In March 1993 *Unforgiven* won 4 Academy Awards, including one for Clint Eastwood the film's Director. *Shindler's List*, directed by Stephen Spielberg, was released in December that year. British artist Rachel Whiteread won both the *Turner Prize* for best, and the *K Foundation Art Award* for the worst, British artist with her temporary public sculpture. The work was a concrete cast of the entire inside of a Victorian terraced house in East London.

In sport, at Wimbledon, Pete Sampras and Steffi Graf won the Men's and Women's tennis singles respectively. Australians Mark Woodforde and Todd Woodbridge (the Woodies) won the Men's Doubles. In cycling Miguel Indurain won both the Giro d'Italia and the Tour de France, and in golf Greg Norman won the British Open.

Australian Events that Made the News in 1993²

On 13 March 1993 the Australian Labor Party led by Paul Keating won the Federal Election, despite opinion polls of the day predicting a Liberal Party win. It was the first time that the Australian Labor Party had won a fifth consecutive Federal election. Many commentators observed that the main reason for the Liberal Party loss was the attempt to introduce a Goods and Services Tax (GST).

On 17 April 1993, AFL player Nicky Winmar made a stand against the racial abuse endured by Indigenous players from spectators and other AFL players. At the end of a St Kilda and Collingwood game, Winmar stood in front of the Collingwood supporters, lifted his jersey, and pointed to his skin, shouting, "*I'm black and I'm proud to be black*". The image of the incident published in newspapers created much public discussion, which eventually led to the implementation, in 1995, of a Code of Conduct for the AFL.

As Juan Antonio Samaranch, President of the international Olympic Committee, uttered the words "...and the winner is ... Sydney" in September 1993, Australia's largest city won the right to host the 2000 Summer Olympic Games. It is only the second time Australia has hosted the games.

In 1992 the High Court of Australia, through the Mabo Decision, recognised traditional land rights for Indigenous people in Australia, effectively rendering *terra nullius* a legal fiction. The Federal Government sought to codify and implement strategies to facilitate the process of recognising native title in Australia and on 21 December 1993 the Native Title Act being passed through Federal Parliament.

Vintage Crop, British-bred and Irish-trained, became the first northern hemisphere horse to win the Melbourne Cup. Shane Warne bowled the "*Ball of the Century*" to Mike Gatting in the first Test at Old Trafford, and in Tennis, Monica Seles and Jim Courier won singles titles in the Australian Open.

Events and Issues in WA Politics in 1993³

The state election was held on 16th February and a 5.3% swing against the Labor Party saw the government of Carmen Lawrence, WA's and Australia's first woman premier, voted out of office. The new Government, led by Richard Court, was formed through a coalition of the Liberal Party and the Nationals.

There were several significant matters that the newly elected Government needed to address: The Mabo Case, Collie Power Station, the McCarrey Report on Public Sector Finances, State and Federal Government relations, the aftermath of the Royal Commission into Commercial Activities of Government (WA Inc), the future of the Environmental Protection Authority and various environmental concerns.

The Report of the Royal Commission into Commercial Activities of Government (WA Inc) released in 1992 had made many recommendations about Government accountability. In the early stage of his premiership Richard Court made the decision that a new body for public sector standards would report directly to himself as Premier, and that existing anti-corruption measures would be further strengthened. Later in the year a Bill for the Commission on Government was drafted.

The Collie Power Station project was as an election commitment for the National Party and Deputy Premier Hendy Cowan. After lengthy debate in Parliament, the power station project was approved, with construction eventually commencing in 1999.

The incoming Coalition Government split the office of Chairman and the Chief Executive Officer of the Environmental Protection Authority (EPA). Both positions had been held for 8 years by Barry Carbon.

There was significant discussion in Cabinet in 1993 about the redevelopment of the WA Museum, reform of Land Tax in WA, maintenance of and future of Stateships, and a strategy for reviewing and monitoring issues surrounding Federal affairs.

Description of the 1993 State Cabinet Records

State Cabinet records include minutes and decisions, agenda, submissions to Cabinet and are listed chronologically. They are the official record the meetings of the State Cabinet of the Court/Cowan Coalition Government held between 16 February 1993 and 20 December 1993 inclusive and are described on SRO's catalogue as *State Cabinet Minutes and Decisions (Series 1228, Consignment 5944)*.

State Cabinet Records and Minutes and Decisions are the primary original source documents that describe decisions made at Cabinet meetings. These documents contain the names of the Ministers present and absent at each meeting, supporting reports, copies, summaries or reviews of submissions, and a record of ministerial recommendations, including decisions, approvals, deferrals by State Cabinet.
