Family and Domestic Violence is considered to be an ongoing pattern of behaviours that aim to coerce, control or create fear within a family or intimate relationship. This includes physical, financial, emotional, or psychological abuse, sexual violence, neglect, intimidation, or any other behaviour which causes you to live in fear.

It can happen to anyone, no matter your age, gender, ethnicity, family ties, religion, ability, or sexual orientation.

If you believe that you are experiencing any of these behaviours, contact your nearest Department of Communities (Housing) office. Our staff are here to help and can discuss how we might assist you.

You can ask to speak with a female, male or Aboriginal officer, and we will do all we can to meet your request.

General Information

When seeking assistance with Housing products and services you will need to complete a Housing Options Assessment. This assessment helps us to identify and understand your housing needs and determine your potential eligibility for various housing products.

Housing Assistance Options

Priority Housing Assistance

If eligible for public housing, you will be placed on the waitlist. The timeframe for allocation depends on the availability of properties in your area of choice and the number of people already on the waitlist.

If you are eligible for Public Housing and a priority need is identified, your application for assistance will be assessed under the Priority Housing Need Policy. Every effort will be made to find accommodation that suits your needs, in your preferred area. In some cases, we may need to consider other locations so that you and those in your care are housed safely and as quickly as possible.

Community Housing

If eligible for Public Housing, you will also be listed for Community Housing to widen your housing choices.

Priority Transfer

If you are a tenant and need to move to a different public housing property due to family and domestic violence, an application for transfer can be made.

Your Housing Options Advice Letter will provide more details on these options.

Supporting Documentation

You will be asked to share some information about your experiences. If you have already shared your story with us or another agency, we can coordinate with them with your written consent.

We may, where appropriate, request supporting documents such as:

- Letters of support from agencies, refuges, or professionals
- Restraining orders
- Police reports
- Statements from third parties, family, or friends.

Safety in Your Tenancy

Communities is committed to maximising your safety and that of your household.

If you need extra security we are here to help. We will install prescribed security measures to your public housing property, for example, window locks, gates, screens, security screen doors and lighting. Simply talk to your Housing Services Officer.

If you ever feel unsafe, or are no longer able to stay at your property, we are here to help explore your options.
