1. Program Overview

Introduction

Western Australia is fast becoming a global hub for health and medical life sciences with our proximity to the growing ASEAN market and strong health leadership.

Western Australia has the skills, research capabilities, infrastructure, clinical trial facilities and business environment to meet the increasing interest and demand for digital health, medical technology (medtech), biotechnology (biotech), pharmaceuticals and health and wellness products and services.

In October 2021, the Western Australian Government announced a Health and Medical Life Sciences Industry Strategy (Strategy) to support the sector's growth as a key sector of *Diversify WA*. This was supported by \$8.65m over four years from the 2022-23 State Budget to implement its five key objectives.

These key objectives are:

- Strengthening the innovation ecosystem
- Facilitating commercialisation
- Developing skills and attracting talent
- Attracting investment
- Supporting infrastructure for advanced manufacturing.

The Department of Jobs, Tourism, Sciences and Innovation (JTSI) is responsible for the implementation of the Strategy. Through delivering programs and policies, these efforts intend to support new and emerging businesses in Western Australia to create jobs and diversify the economy.

About the Market Access Grant Scheme

The Market Access Grant Scheme (MAGS) provides grants of up to \$5,000 per Western Australian company working in health and medical life sciences, to travel to major industry conferences or business events. MAGS 2025 supports grants in the 2025 calendar year.

The program is delivered by JTSI and aligns with the Strategy's government focus by "*facilitating access to market information and international conferences*".



MAGS is designed to:

- Assist Western Australian companies working in health and medical life sciences to advance their business and products;
- Assist them to build business relationships and get exposure to new markets in order to grow their commercial opportunities and jobs; and
- Showcase talent and build the profile of the Western Australian industry;

The MAGS supports travel to and/or participation in major domestic or international events that relate to the health and medical life sciences industry. These can be:

- Conferences
- Expos
- Exhibitions
- Showcases

Funding

- A maximum of \$5,000 (excl. GST) per company is available to support travel of one representative. There is no minimum amount. Applications seeking funding in excess of \$5,000 will not be considered.
- Recipients are required to provide a net cash co-contribution of at least 20:80 applicant-to-Western Australian Government funding.
 - For example, a travel cost of \$6,250 (total cost excluding GST) would involve the recipient providing a minimum of \$1,250 (plus any GST), from their own means, to supplement the \$5,000 grant.
- To be eligible for MAGS 2025 travel must be completed by 31 December 2025 and acquitted within 30 days of undertaking travel. Prior to receiving funds, successful grant applicants must enter into a signed FAA with JTSI (Conditions and Obligations for Funding).
- Upon notification of success in the MAGS 2025 round, recipients may book and purchase air tickets and conference passes to capture early bird specials from the date of notification, prior to the FAA being executed. MAGS cannot be used to support reimbursement for costs incurred prior to notification of a MAGS award. That is, any expenditure prior to notification will not be reimbursed.
- This agreement must be executed (signed) before funding is received. Successful grant applicants will receive 90 per cent of the grant up front. The remaining 10 per cent upon acquittal.



- Grant recipients should note that if it is determined, during the acquittal and post-project reconciliation process, the project has unspent grant funds, those funds must be returned to JTSI, following processes as outlined in the FAA.

Eligibility Criteria for MAGS 2025

Applicants are eligible if they:

- Have applied through mags.grantplatform.com.
- Live in Western Australia.
- Are a company that operates in the Health and Medical Life Sciences sector and are developing or expanding health and medical life science technology in Western Australia (does not extend to include consultants).
- Are not requesting funding for activities that are supported through another funding program external to your company.
- Are a registered business based and headquartered in Western Australia plus at least one of the following:
 - Have been operating for at least 24 months at date of application
 - Are a spin-out of a university or medical research institute
- Your business is targeting a market(s) for your partnering, investment, export and/or trade activities.
- Your business/organisation is a small to medium enterprise that employs fewer than 200 people or a not-for-profit group/industry association/business council that employs fewer than 200 people and is a legally constituted not-for-profit organisation recognised by JTSI.
- Your business/organisation holds at least one of the following:
 - A valid Certificate of Incorporation
 - A current Australian Business Number (ABN)
 - A current Australian Company Number (ACN)
- Your business/organisation is a legally solvent entity.
- Your business/organisation is willing, and has the financial capacity to contribute, at least 20:80 applicant-to-Western Australian Government funding.
- Your business/organisation confirms that only one application by your company has been submitted for the grant.



- Your business/organisation confirms that it will utilise the funds (if successful) only on eligible travel costs to the stipulated major industry conferences or business events.
- Your business/organisation confirms that the requested eligible expenditure is for future activity that will commence in and be completed in 2025.
- Can justify alignment with the Health and Medical Life Sciences Strategy and the proposed outcomes generated for your business and Western Australia.
- Can demonstrate a proposed travel budget with quotes and costs to the value of your asking amount.
- Your business/organisation has NOT previously received nor is likely to receive other Western Australian Government funding, for the same project/initiative.
- Declare any funding received or likely to be received from Commonwealth or other State/Territory Government agencies for the same project/initiative.

Eligible Expenditure for MAGS 2025

MAGS 2025 is a limited access grant. The grant funds can be used towards:

- Event registration/access cost.
- Event exhibitor space/booth.
- Associated business events (i.e official conference dinners – does not include travel meals).
- Economy airfares.
- Accommodation (moderately priced hotels – 3 or 4 stars).
- Ground transportation.
- Visas.
- Travel Insurance.

A draft Budget will be required along with the applicant's grant submission that includes quotes for any of the applicable expenditure items.

How to apply

Applications must be submitted using the online form that can be accessed at mags.grantplatform.com

Applications for MAGS 2025 are limited to one successful application per company, to support one representative commencing and completing travel during the 2025 calendar year.



The applicant will not need to nominate the staff member at the time of application. The staff member using the grant must be a full time employee of your company at time of use.

Decision Making Process

Applications are assessed against the Eligibility Criteria, and Eligible Expenditure outlined above.

JTSI will review the Eligibility Criteria to determine shortlisted applications based on the criteria outlined above, and to make recommendations for funding.

To assist with decision making, JTSI may seek advice from individuals with expertise in the area/s under consideration.

JTSI may also request further information from applicants if needed, to support claims against the evaluation criteria.

JTSI decisions and all related information and material are strictly confidential, subject to the requirements of the *Freedom of Information Act 1992* (see Conditions and Obligations 1.8).

The final approval for applicant funding lies with JTSI. JTSI’s decision is final and no further correspondence will be entered into.

MAGS 2025 applications will be considered until December 9th unless **funds are exhausted**. In the event that funding is exhausted, MAGS 2025 will be closed to new applications. Information regarding closures will be published on the website and mags.grantplatform.com portal.

Caretaker Mode

The WA government will enter caretaker mode in early 2025 for the upcoming State election. During this period we will be unable to accept any new MAGS applications.

The Timeline for the Grants Process

The table below provides indicative timing:

Steps in the process	Timing
MAGS 2025 Opens	29 October 2024
MAGS 2025 Closes	The earlier of the following two dates: The date that funding is exhausted or 9 December 2024. NB: Re-opening of the round may be considered in 2025.
Assessment and notification of outcomes to applicants	Within 14 days of application submission
Execution of Financial Assistance Agreement	Within 5 days of notification of outcome
First payment	With 14 days of the execution of the Financial Assistance Agreement



Completion of activities	No later than 31 December 2025
Claim for final payment submitted	Within 30 days of travel

Travel activities

The MAGS 2025 supports travel to and/or participation in major domestic or international events that relate to health and medical life sciences such as:

- Conferences
- Expos
- Exhibitions
- Showcases

The events need to take place within the 2025 calendar year and travel must commence and be completed in 2025.

Outcome Communications and Feedback

Applicants will be notified of the outcome of their application via the email address provided by the applicant in the application form.

The Hon Stephen Dawson MLC, may announce the successful applicants in a media statement. As part of this, JTSI may disclose select details such as business and project aims and expected outcomes. Recipients agree to disclosure of this information as part of the FAA with JTSI.

Due to confidentiality, feedback cannot be provided on the Evaluation Panel's deliberations.

Conditions and obligations for funding

- The grant will be on a co-investment basis at a ratio no less than 20 per cent (applicant) to 80 per cent (State Government) funding. Co-investment items cannot be in-kind and may be subject to an independent audit.
- Successful applicants will be required to enter into a legally binding FAA with the Western Australian Government acting by and through JTSI.
- The terms and conditions of the FAA will not be negotiable at the time a funding offer is made.



- The funded project must be completed no later than 31 December 2025
- Only eligible expenditure incurred after the notification of receipt of a MAGS award can be claimed by successful applicants.
- Applicants are responsible for any/all additional costs incurred by them as a result of fulfilling their obligations under the grant and FAA.
- The Western Australian Government will not accept liability for any damages, losses, liabilities, costs and expenses claimed or incurred by the successful applicant in connection with this grant.
- An upfront payment of 90 per cent will be made after the FAA is signed by the successful applicant and endorsed by JTSI. The final 10 per cent of funding will be provided on acquittal after you have completed your travel. It will be based on relevant invoices and/or quotations itemised in the proposed project's budget. On conclusion of the project, grant recipients must ensure that project cost estimates correspond with final proof of purchase receipts.
- Payments to successful applicants will be made via electronic funds transfer upon assessment of claims and evidence, to the satisfaction of JTSI.
- JTSI's view is that the grant is not regarded as payment for a supply and, therefore, does not incur GST. Furthermore, JTSI will not reimburse a grant recipient for GST paid or payable to a third party.
- Failure to provide all necessary information may result in forfeiture of all or part of the grant.

Acquittal report

Following project completion, successful applicants must provide within 30 days:

- A final acquittal report, which must be submitted to JTSI.
- Proof of payments for the project/eligible expenditure, which are either included in the online form or emailed to lifesciences@jtsi.wa.gov.au.
- Proof of project completion, including acknowledgment of the travel and a report on the outcomes.
- Or such other information required by JTSI as evidence of eligible expenditure and completion of the project. Failure to provide the above information may result in forfeiture of all or part of the grant.

Availability of funding

The provision of financial support under this program is at the absolute discretion of the State of Western Australia and is subject to the availability of funds.



Audit, compliance and risk management

As a Western Australian Government agency, JTSI is required to ensure the most prudent and effective use of its financial assistance schemes.

Grant recipients will, therefore, be required to:

- Liaise closely with JTSI to assess whether expected outcomes are being achieved.
- Provide, if requested, additional information that may assist JTSI's internal audit, evaluation and review processes.
- Respond, if requested, to a client survey. The survey is used to obtain general feedback from clients on the effectiveness and efficiency of JTSI's services.

Conflict of interest

Applicants are required to disclose any information that may be relevant to an actual, likely or perceivable conflict of interest.

Review of program

This program is subject to an internal review at the end of each financial year. The guidelines may be updated periodically to reflect any changes in the program, priority sectors or markets.

Participation in review of project and surveys

All financial support provided by JTSI under this program is subject to a post-funding review. Recipients must make themselves available to participate in surveys conducted by JTSI up to two years after the funding ceases. Surveys are generally 5 to 10 minutes long and seek feedback on inputs, activities, results, usage and impacts related to the funding.

Release of confidential information

The content of all applications will remain strictly confidential. JTSI will store personal information collected in this process, supporting documentation and any payment administration, monitoring and evaluation activities in compliance with its obligations in the *Privacy Act 1988*.

Successful projects may be promoted in a way that retains the commercial integrity of the project in the public domain.

Government records are subject to the *Freedom of Information Act 1992* (Western Australia), which provides a general right of access to records held by Western Australian State and local Government agencies. Exemptions do apply in certain circumstances. Further information on the *Freedom of Information Act 1992* (Western Australia) can be obtained from JTSI's website.

By submitting an application to this grants program, the Applicant consents to information provided by the Applicant or collected by JTSI relating to the Applicant or their Application being



used by JTSI to assess their application, administer funding under the MAGS, and administer FAAs relevant to this grants program.

Media and promotion

Grant recipients are required to formally acknowledge the grant throughout the life of the project across any social, digital and/or onsite promotional opportunities once the Minister has formally announced the recipients.

Recipients may be provided with a Media Tool Kit to assist in promotional work and will be asked to consent to provide contact details, including a name, phone number and email address, to be shared for media and promotional purposes.

Disclaimer

The provision of financial assistance by the State Government is at its absolute discretion. Nothing in the application process or the selection process shall give rise to any legal relationship or any other obligations between the applicant and the State.

Any obligations and responsibilities of the parties will be the subject of an FAA between the Western Australian Government and successful applicants.

How Will Final Awards be Decided?

JTSI will consider the scores of the assessors, the applicant's award preferences and our own research to identify the top candidates.
