#### What is a hearing?



A **hearing** is when you meet and talk with people.



Hearings take place at the State Administrative Tribunal.



The **State Administrative Tribunal** is also called SAT.



The **State Administrative Tribunal** building is in Perth.



The **State Administrative Tribunal** building is fully accessible.

## What if you need to attend a hearing?



You may need to attend a hearing.



You can attend a **hearing** if you have a mobility concern.



You can attend a **hearing** if you use a mobility aid.



You may be able to attend a **hearing** online or on the phone.

You will need to ask SAT if this is possible.



If you have any queries about attending a **hearing** you can contact the **State Administrative Tribunal**.

### What if I drive to the hearing?



If someone drives you to the **State Administrative Tribunal** building, there are drop-off bays outside.



They are marked with this blue sign.



The bays can be used to drop someone off.



The bays cannot be used for parking.
