## This Action Plan supports strategic action areas outlined in Western Australia's 10-Year Science and Technology Plan, to address challenges faced by the State, create jobs and boost the economy.

#### Over the next 10 years, Western Australia will:

- » Increase investment in research and development by government and industry.
- » Deliver effective collaborations that support partnerships between industry, academia and government.
- » Create a growing, diverse and globally connected science and technology talent pool.
- » Establish an innovative, state-based approach to supporting new critical science and technology infrastructure.
- » Have strong community engagement and globally renowned leadership, informed by a multidisciplinary Science and Technology Council.

### Strategic action areas

The Western Australian Government's focus is directed across six strategic action areas:

- 1. Talent, skills and workforce
- 2. Funding and investment
- 3. Physical and digital infrastructure
- 4. Leadership, collaboration and communication
- 5. Translation, commercialisation and procurement
- 6. Policy, regulation and governance.

3.5.	Investigate optimising funding and support for statewide research infrastructure through the establishment of a <b>State</b> Research Infrastructure and Equipment Co-Investment Fund.	JTSI
3.6.	Conduct a feasibility study into the establishment of a statewide <b>Biobank</b> for the storage of non-human, biological samples for use in research.	JTSI
3.7.	Review Western Australia's current data storage and processing capabilities for research and development.	JTSI/DPC
3.8.	Support a data linkage forum to foster strong collaboration with the research sector.	DPC
